

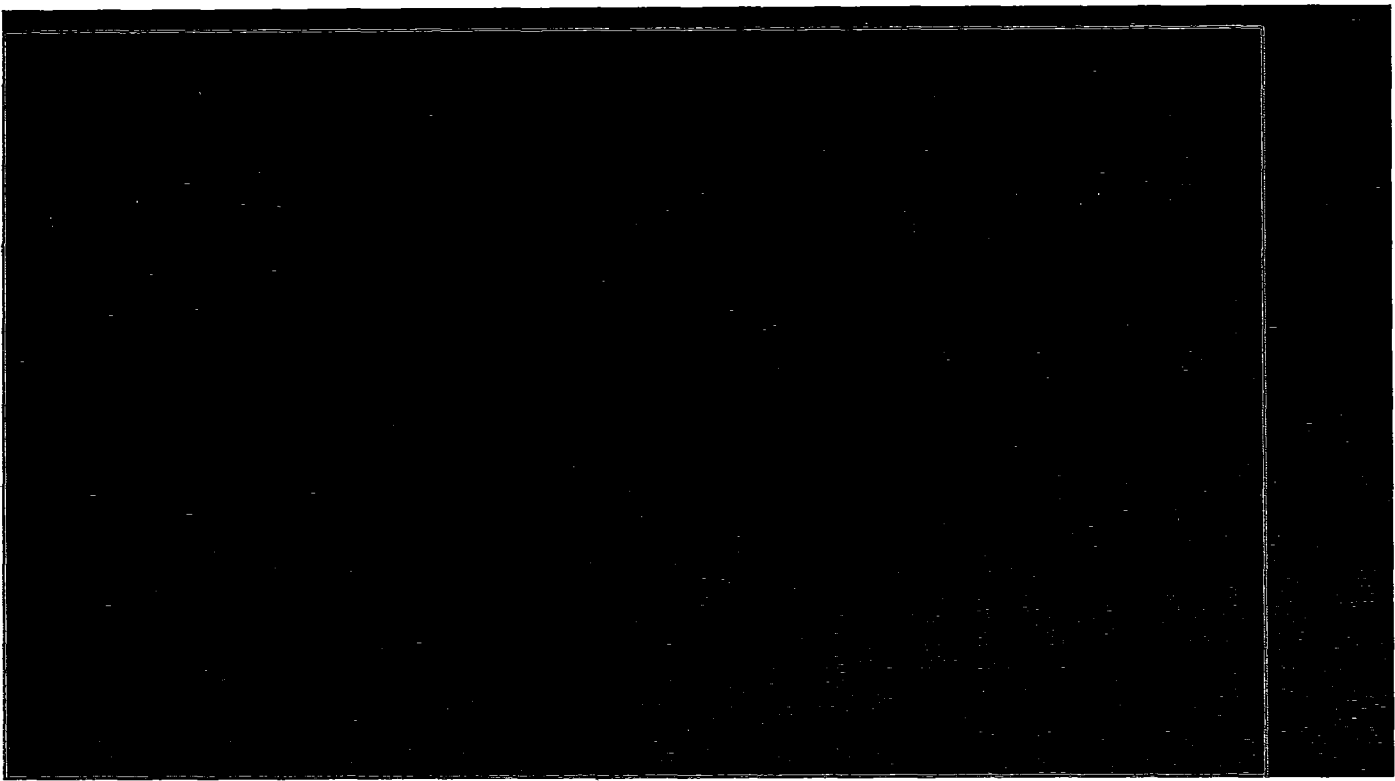

Japan, Australia Agree To Resume FTA Talks Next Month

**NUSA DUA, Indonesia (Kyodo)**--Japanese Prime Minister Yoshihiko Noda and his Australian counterpart Julia Gillard agreed Saturday to resume bilateral talks on a free trade agreement next month, Japanese officials said.

Japan and Australia were originally scheduled to hold such talks in April but they were postponed in the wake of the catastrophic March 11 earthquake and tsunami in northeastern Japan. They have been engaged in FTA negotiations since 2007.

The two leaders reached the agreement during talks on the sidelines of Association of Southeast Asian Nations -related summits on the Indonesian resort island of Bali.

Noda also informed Gillard about Japan's decision to enter into dialogue with concerned parties regarding the Trans-Pacific Partnership free trade talks, the officials said.

Gillard welcomed Japan's decision and said she hopes to see the TPP become a comprehensive and high-quality agreement, according to the officials.

Australia has been one of the five countries, together with the United States, Malaysia, Peru and Vietnam, with which negotiations to expand the TPP have been under way. The TPP is originally an agreement between Singapore, Brunei, Chile and New Zealand.

With an eye to deepening bilateral security cooperation, Noda and Gillard agreed to hold the next foreign and defense ministerial talks at an early date, the officials said.

Noda also welcomed a recent accord between the United States and Australia to deploy U.S. Marines to Australia's northern shore, the officials said.

The dispatch is regarded as deepening the U.S. military presence in the Asia-Pacific region amid China's growing maritime assertiveness, especially in South China Sea, which contains overlapping territorial interests between China and some ASEAN members.

Japan's Participation In TPP Talks Alarms China

BEIJING (Nikkei)--China is alarmed by Japan's decision to join Trans-Pacific Partnership negotiations, since Beijing's hoped-for free trade agreement encompassing the Association of Southeast Asian Nations plus China, Japan, and South Korea will be put on the back burner.

"Japanese participation in TPP talks will be a negative for East Asian economic cooperation," Li Xiangyang, director of the Institute of Asia-Pacific Studies at the Chinese Academy of Social Sciences, told The Nikkei.

Li, who is deeply involved in China's trade policymaking, also warned of likely delays to any trilateral free trade agreement. There were hopes that talks among Japan, China and South Korea would begin next year.

Originally, China sought an economic alliance based on the ASEAN+3 framework -- which doesn't include the U.S. Japan, which had feared China's increased influence in such a setup, had pushed for an ASEAN+6 framework, bringing India, Australia and New Zealand into the mix.

The Chinese view Japan's decision on the TPP as aligning Tokyo with the U.S. camp, according to Li. "There's virtually no chance of China joining the TPP in the foreseeable future," he said.

South Korea, which is expected to ratify a free trade pact with the U.S., was "surprised" by Japan's move, said a senior government official. Because of Japanese reluctance to open its agricultural and fisheries market during past negotiations for a bilateral economic partnership, the official doubts that Japan "can overcome domestic opposition and truly participate."

South Korea is negotiating or has concluded FTAs with all TPP nations except Japan. Seoul sees little real need to rush into the pact. But it will monitor the talks' progress, since the TPP will effectively be the axis of a free trade zone in the Asia Pacific region if Japan does join.

India, meanwhile, will not participate in the TPP, Commerce Minister Anand Sharma told The Nikkei. It is instead seeking a broad economic zone that includes India along with ASEAN+3 and other countries, he said.

Welcoming Japan to the negotiating table were nations already engaged in the talks.

Singapore has nothing to lose with Japan's participation, since it has already eliminated import tariffs.

Australia's Trade Minister Craig Emerson said Friday that Japan's commitment "to such an ambitious project would be an extremely positive development."

And Vietnam believes its seafood and apparel exports will grow if Japan does join the pact. Hanoi is apparently counting on Japan to align with Vietnam against the U.S. at the TPP negotiating table.



Japan to make decision on TPP next week

TOKYO -

The Japanese government will make a decision on whether to join the Trans -Pacific Partnership free trade talks by next week.

Both Chief Cabinet Secretary Osamu Fujimura and Trade Minister Yukio Edano told separate news conferences that Japan has been quite late in making a decision but will do so by the Nov 12 -13 Asia-Pacific Economic Cooperation (APEC) meeting in Honolulu.

Fujimura also said that even if Japan signals its willingness to take part in the talks, the framework for the multilateral talks is not likely to be decided until well into next year, Jiji Press reported.

The TPP is a multilateral free trade agreement that aims to further liberalize the economies of the Asia-Pacific region. The original agreement between the countries of Brunei, Chile, New Zealand and Singapore was signed on June 3, 2005, and entered into force on May 28, 2006. Five additional countries - Australia, Malaysia, Peru, United States, and Vietnam - are negotiating to join the group.

On the last day of the 2010 APEC summit, Nov 14, leaders of the nine negotiating countries endorsed the proposal advanced by U.S. President Barack Obama that set a target for settlement of negotiations by the next APEC summit in November 2011.

However, with the APEC summit in sight, Fujimura told a news conference, "Negotiations are likely to take a year. It's not going to happen next week. So we have five Diet sessions dedicated to discussion of our participation in the TPP."

The issue has become a highly divisive (sic) one in Japan.

Japanese farmers are vehemently opposed to joining out of fear that food imports would ruin them. The Central Union of Agricultural Cooperatives, backed by 161 ruling party and opposition lawmakers, have denounced the TPP, accusing the government of abandoning the agricultural sector and ignoring their opinions.

Meanwhile, supporters of Japan's participation in the TPP said delaying the decision to join the talks will widen the gap between Japan and its competitors in the global market.

EDITORIAL: Dispel Myths About TPP For Proper Debate

TOKYO (Nikkei)--A noisy debate is raging over whether Japan should sign on to Trans-Pacific Partnership. Unfortunately, ignorance about the content of the negotiations is creating a lot of unjustified opposition to the proposed free trade pact.

It will be impossible to have an informed discussion on such an important issue if worries about the agreement are colored by false information. The government has been in touch with the countries taking part in the TPP talks and must have a good grasp of how the negotiations are going.

To end misunderstandings about the TPP, the government should disclose all the information it has obtained thus far, and explain the talks to the public in detail. Failure to do so will give momentum to opponents of the agreement, some of whom are acting to protect their own vested interests.

Phantom fears

Seiji Maehara, policy chief of the ruling Democratic Party of Japan, has described unfounded worries about the talks as the "TPP ghost." Shizuka Kamei, head of the People's New Party, the DPJ's junior coalition partner, has said what is monstrous is that only the government knows what the group is about.

Bickering among the politicians that fails to clarify points of contention will only serve to intensify public misgivings. The government must therefore provide concrete answers to people who have doubts and fears about the TPP.

Some fear that joining the TPP may destroy Japan's universal healthcare system by, for instance, lifting the ban on medical treatment that is partly covered by the national healthcare program and partly paid at patients' own expense. That idea has drawn opposition from doctors and other medical professionals, but a "mixed treatment" healthcare system is not on the TPP agenda.

Others are concerned that safety standards for genetically modified farm products, food additives and pesticides might be lowered. But the talks will not touch on those matters because under World Trade Organization rules, members can devise their own health and safety rules, so long as they are based on scientific evidence.

Still others argue that joining the TPP could threaten domestic employment, causing an inflow of foreign workers, including doctors, lawyers and other experts. But neither are labor market issues up for discussion. And whatever the outcome of the TPP debate, discussions on domestic regulatory reform should continue.

The notion that the agreement will completely scrap tariffs on all traded goods and services, including farm products, as soon as the TPP takes effect is also false. Tariffs are to be lowered gradually over a long period, say, 10 years, to give domestic producers time to adjust.

A common theme raised by opponents of the TPP talks is that pressure from the U.S., which is spearheading the negotiations, may harm Japan's national interest. To dispel such misgivings, the government must explain to the public what it is hearing from the parties to the talks, particularly the U.S.

Maehara, Kamei at odds over whether Japan should join TPP

DPJ policy affairs chief Seiji Maehara and Shizuka Kamei, who heads the People's New Party, the DPJ's coalition partner, have clashed over whether Japan should join the U.S.-led Trans-Pacific Partnership free trade talks.

The ruling party has started intensive discussions in an attempt to make a decision by the time Prime Minister Yoshihiko Noda attends the Nov 12-13 Asia-Pacific Economic Cooperation, or APEC, meeting in Honolulu. Tokyo had put off a decision in the aftermath of the March 11 earthquake and tsunami.

Maehara kicked off the sparring match by showing his opposition to the agreement in controversial terms. Maehara said on a TV program over the weekend that he is against the TPP partnership and called the free trade agreement "a monster."

Kamei responded on TV Asahi, criticizing Maehara for the comment, which he deemed inconsiderate and brash.

One media analyst said in reference to Maehara's statement that the DPJ will lose its supporters with "that type of babble."

Noda has already said that he is in favor of Japan joining the TPP, calling it an engine that will spur Japan's economic growth.

Opponents of the TPP in both the ruling and opposition parties say that it would pose a threat to Japan's heavily protected agricultural sector.

Japanese businesses fear impact of U.S -South Korea FTA

A sense of panic is spreading among Japanese companies after the U.S. Congress passed a bill on a free trade agreement with South Korea.

The passage of the bill on Oct. 12 smooths the way for the FTA to take effect in January, which both nations are aiming for. It also strengthens South Korea's boast that it is the hub of free trade in Asia.

Seoul has been very proactive in striking FTAs with other countries and territories, while the Japanese government has been sluggish on this front, despite repeated calls from Japanese businesses for an acceleration of FTA negotiations with other countries that will allow them to keep pace with their South Korean rivals.

"We must further strengthen our economic relationships (with other countries) to bring in more foreign currency," said Hiromasa Yonekura, chairman of Keidanren (Japanese Business Association), Japan's largest business group.

The U.S.-South Korea FTA is of huge concern to Japan's auto industry, which has felt the impact of the intensified competition from South Korean carmakers in the global market.

According to the Japan Automobile Manufacturers Association (JAMA), the auto market in countries that have approved FTAs or economic partnership agreements with South Korea is 35.1 million units, nearly seven times the 5.7 million units in overseas markets that have signed such agreements with Japan.

Japanese automakers have increased their overseas production in recent years, but their exports still account for a large portion of their output. About 30 percent of their vehicles are exported to the United States.

"We want the government to allow us to compete with South Korea under the same conditions," Toshiyuki Shiga, chairman of the JAMA, said.

But Tokyo has yet to even announce its participation in negotiations with the United States and other nations on building the framework of the Trans-Pacific Partnership free trade agreement.

Given the situation, Toyota Motor Corp. will relocate production from Japan to the United States of its flagship Camry medium-size sedan for sales in South Korea, taking advantage of the expected reduction in export costs under the U.S.-South Korea FTA.

The U.S.-South Korea FTA is not expected to seriously affect major Japanese electronics manufacturers, many of which have taken measures to cope with the strong yen and increased production overseas.

Panasonic Corp. and Sharp Corp. assemble TVs in Mexico, a country with which Japan and the United States have established an FTA. Their moves signify that FTAs carry more weight now in choosing sites for investments.

The countries and territories with which Japan has clinched FTAs and EPAs account for only 18.2 percent of the country's total trade value, or about half of the 35.3 percent for South Korea after the U.S.-South FTA takes effect.

A report on the TPP released last year by the Ministry of Economy, Trade and Industry treated South Korea as a clear rival.

The report described a worst-case scenario if Japan does not join the TPP and fails to reach FTAs with the European Union or China while South Korea establishes FTAs with the United States, the EU and China. The report said Japan's real gross domestic product would drop 10.5 trillion yen (\$136 billion) and 812,000 people would lose their jobs.

METI views the U.S.-South FTA as a step closer to this worst-case scenario.

The ministry says Japan's participation in the TPP holds the key to catching up with South Korea in building free trade networks.

If Japan joins the TPP, the trade proportion figures for Japan will reach the same level as those of South Korea, according to the ministry.

The government is expected to soon make a decision on participating in negotiations on the TPP, which was delayed after the March 11 Great East Japan Earthquake. However, Prime Minister Yoshihiko Noda faces a huge challenge from a group within the ruling Democratic Party of Japan, which collected more than 190 lawmaker signatures from inside and outside of the party opposing the TPP.

The opponents say that joining the TPP would devastate Japan's agriculture industry.

South Korea has not outlined any plans to participate in the TPP, but opposition would be limited given the country's FTA with the United States.



"It would be unbearable if South Korea became a TPP member ahead of Japan and was in a position to determine whether Japan is allowed to join the partnership," a METI official said.

DPJ Holds 1st Meeting Of TPP Project Team, Discussion Heated

TOKYO (Kyodo)--The ruling Democratic Party of Japan on Friday held the first plenary meeting of its project team tasked with considering whether Japan should join negotiations for the U.S.-backed Trans-Pacific Partnership free trade framework, with participating lawmakers engaging in heated discussions.

At the outset of the meeting, Yoshio Hachiro, the head of the project team and a former trade minister, said, "I would be delighted if we can reach a certain consensus on the TPP through aggressive discussions here."  
Prime Minister Yoshihiko Noda has said Japan will decide on whether to join the trans-Pacific free trade negotiations at an early date, as the nine countries involved in the talks aim to reach agreement on a broad outline of the deal at the Asia-Pacific Economic Cooperation forum summit in Honolulu in mid-November.

But members of both the Cabinet and the ruling party remain at odds over the issue.

At the meeting of the project team, some participants, including Masahiko Yamada, a former farm minister who does not want Japan to join the TPP talks, complained that the team's board consists mainly of lawmakers supportive of participation.

Opponents of the TPP also called for the team's meetings to be fully open to the press in order to ensure discussions are transparent to the public.

Friday's meeting was only partially opened to the press.

During the first half of the meeting when reporters were allowed to observe, Yamada, who heads a political group calling for "cautious" consideration of the TPP, said, "There are too many problems in the TPP with regard to sectors such as services, medical care and drugs."

"I will never understand why we have to rush so much (to decide on the matter)," Yamada said.

There is strong opposition among Japanese farmers who fear an influx of cheap agricultural imports if Japan joins the free trade pact involving major farm exporters such as the United States and Australia. In principle, the TPP would eliminate all tariffs on imports.

The Japan Medical Association has also voiced concern over the country's participation in the TPP talks, with an executive member saying the deal could lead to the entry of foreign medical services into Japan and encourage a profit-oriented economy in the domestic medical sector.

Meanwhile, TPP advocates say if Japan fails to decide on joining the negotiations soon, it could lose an important opportunity to take part in the rule-making process for the free trade framework.

Hachiro said, "From a broad perspective, I think Japan would benefit greatly from taking a leadership role in the rule-making process in the Asia-Pacific region."

The DPJ's TPP project team is scheduled to hold its second and third meetings on Monday.

PM indicates intention to join TPP talks / Aiming to announce at Nov. forum

Prime Minister Yoshihiko Noda has instructed concerned ministries and agencies to begin preparing to join negotiations for the Trans-Pacific Partnership trade agreement, indicating his intention to announce Japan's participation when he attends a November summit meeting of the Asia-Pacific Economic Cooperation forum in Hawaii, government sources said.

The United States and eight other APEC countries are holding talks to reach a basic agreement about the TPP. Noda apparently judged it necessary for Japan to join in the process of compiling rules for the TPP, the sources said.

Agricultural and some other organizations oppose joining the TPP, out of concern that lowering tariffs under the free trade pact could bring a flood of imported products into the domestic market.

Within the ruling parties, lawmakers with ties to farming industries have formed a league and are collecting signatures of TPP opponents.

In the government, Agriculture, Forestry and Fisheries Minister Michihiko Kano has also opposed joining the TPP talks.

Attention will be focused on how the prime minister will persuade opponents. Azuma Koshiishi, secretary general of the Democratic Party of Japan, said Saturday on a TV Tokyo program, "After discussions [within the DPJ], I want the prime minister to be able to send a firm message on Japan's behalf at the APEC meeting."

Koshiishi expressed his intention to coordinate opinions within the DPJ by the APEC meeting, which will be held Nov. 12 and 13.

Noda planned to visit farming households in Gunma Prefecture on Monday, to express his intention to implement measures to improve productivity and thereby strengthen the nation's agriculture.

Noda is considering actions similar to those after Japan liberalized rice imports in the 1993 Uruguay Round trade agreement. At that time, the government implemented measures worth about 6 trillion yen to support agriculture.

Among the measures the government is considering are large-scale fiscal expenditures.

Noda aides have also suggested telling opponents that Japan can leave the TPP negotiations if it decides at some point there would be a negative impact on the nation.

At a summit meeting in September with U.S. President Barack Obama, Noda told Obama Japan would decide as soon as possible whether to join the TPP negotiations.

Noda's leadership to be tested

The lawmakers' league opposing the TPP, led by former Agriculture, Forestry and Fisheries Minister Masahiko Yamada, had collected signatures from 180 Diet members as of Saturday.

Yamada said most of the signatories are DPJ members, and he will submit the list to the government when the number exceeds 200.

The league plans to organize a large rally soon to urge opposition to joining the TPP.

"We'll fight with firm determination," a senior member of the league said. The member also emphasized the group's intention not to be persuaded by pro-TPP lawmakers.

Former DPJ President Ichiro Ozawa is said to be cautious about Japan joining the TPP.

A Diet member in the Ozawa group said, "Economic partnerships comprising a limited number of countries will divide the world economy into blocs and may cause confrontations among blocs, like those around the time of World War II."

The government wishes to draw on demand in other Asian markets to fuel Japan's economic growth, and believes joining the TPP would aid in that purpose.

DPJ Policy Research Committee Chairman Seiji Maehara and former Secretary General Katsuya Okada are pro-TPP.

Noda will have the DPJ's project team on economic partnership start working this week to reach an intraparty conclusion about the TPP talks before the APEC summit meeting. The team is chaired by former Economy, Trade and Industry Minister Yoshio Hachiro.

But the team will likely comprise both pro- and anti-TPP members, such as Okada and Yamada. Thus, bridging the opinion gaps will be difficult and the debates will be a race with time.

To persuade anti-TPP party members, some in the government are considering large-scale fiscal spending to revitalize agriculture. However, some DPJ members have voiced doubt whether the government can find the funding for such measures.

9 Nations Give Up Concluding TPP Talks By APEC Summit

SINGAPORE (Kyodo)--Nine nations participating in Trans-Pacific Partnership free trade talks have given up on concluding the negotiations in time for the November APEC summit in Hawaii, several trade sources said Saturday.

Their working committee is planning to meet in Malaysia in December to continue the talks, according to the sources.

The nine include Australia, Singapore, Peru, the United States and Vietnam.

The move apparently reflects the conflicting opinions among the respective parties on how to break down trade barriers, and gives Japan more time to consider its position on joining the talks, after having fallen behind in the face of domestic opposition, particularly from the agriculture sector.

While the U.S. government had shown willingness to conclude the talks by the November summit of the Asia-Pacific Economic Cooperation forum, some observers said it would be difficult to make substantial progress in the talks until the U.S. presidential election is over next year.



EDITORIAL: It's time to put fears about TPP to rest

One important trade policy question facing the government is whether Japan should participate in talks on a Trans-Pacific Partnership (TPP) agreement.

Nine Pacific Rim countries, including the United States and Australia, are currently engaged in negotiations with an eye to striking a deal on an outline of the agreement in November.

This target date sets a timeframe for Japan to decide whether to join the TPP talks.

We have been calling on the government to join the talks. The TPP accord has the potential to become the foundation for free flows of goods and services in the fast-growing Asia-Pacific region.

Japan has an obvious interest in helping to develop the TPP rules if it wants to avoid being at a disadvantage in regional trade.

It should at least join the negotiations. If it then concludes the trade pact doesn't serve its interest, it can simply decide not to sign it.

The government had said it would wait until June to announce whether it will join the talks. But the decision was put off due to March 11 Great East Japan Earthquake.

In the meantime, a broad array of concerns about the TPP has been raised by various people and businesses in Japan.

To put the process of developing Japan's policy for the trade talks on track, the government needs to explain the current state of negotiations so

that cool-headed, fact-based debate on the issue can be held.

The main obstacle to Tokyo's participation in the TPP negotiations lies in the agricultural sector, where many products are protected by high tariffs from international competition in the domestic market. Rice is the most notable example.

One of the TPP's basic principles calls for trade liberalization without an exception. In the actual negotiations, however, the participating countries are seeking to exempt certain items to ease opposition to free trade in the products from related industries.

The United States, which is leading the talks, has had some farm products, including sugar, exempted from its bilateral free trade agreement with Australia. Washington has also made sure that the process of phasing out the tariffs on many other products will be stretched over a period longer than the 10-year limit imposed by the principles for trade talks.

The United States has adopted a similar strategy for the TPP negotiations.

Japanese farmers and others in the agricultural sector have voiced concern that participation in the TPP could lead to the immediate scrapping of tariffs on all products. But that fear is unfounded.

Japan should adopt a strategic approach to deal with the challenge. The government should act swiftly to put together a package of policy measures to bolster the international competitiveness of Japanese agriculture, including steps to promote larger-scale farming. It also should seek through the negotiations to secure the time and terms that allow it to implement such measures.

But concerns over the trade pact are not limited to the abolition of tariffs.

Some TPP critics warn that the agreement would lead to massive inflows of unskilled foreign workers, while others predict that Japan would be forced to fundamentally revamp its public health care system.

Opponents also argue that the pact would undermine Japan's efforts for environmental protection while forcing the nation to import food products from countries that don't adopt food safety standards that are as strict as those in Japan.

These opponents are raising issues of so-called social regulation, or government regulation that addresses specific social problems such as pollution and product safety. These issues should be discussed from viewpoints other than the revitalization of the economy, which is the principal justification for most arguments for deregulation.

Based on information they have collected, Japanese trade officials claim that many of the concerns that have been raised in relation to the TPP are not founded in the actual topics at the negotiation table.

To allay unnecessary anxiety about the TPP, the government should offer detailed explanations about how the talks are going and its own thoughts about the trade agreement.

With the yen stuck at historically high levels against other major currencies, there is mounting concern about the hollowing out of Japanese industries.

Besides the elimination of tariffs, the TPP talks are also addressing many issues that are important from the viewpoint of promoting Japanese exports, such as the simplification of trade procedures.

Policymakers should explore ways to overcome the differences in domestic opinion over the TPP, which are simplified as conflict between agriculture and manufacturing. They need to figure out a formula for using the TPP as a means to re-energize Japanese industry. That is a key trade policy mission for the administration of Prime Minister Yoshihiko Noda.

Tug of war over TPP will intensify in divided DPJ By MAYUMI MORI / Staff Writer The Asahi Shimbun Although Japan promised the U.S. it will decide as soon as possible on joining the Trans-Pacific Partnership (TPP) free trade initiative, it is unclear when a decision will be reached due to fierce opposition within the ruling party.

Prime Minister Yoshihiko Noda pledged to President Barack Obama in their meeting in New York on Sept. 21 that Japan will "reach a conclusion (on the matter) at an earliest possible date."

While Obama welcomed the news that Japan has started discussions on participating in the TPP, Noda did not offer any time frame for a decision.

Following Noda's promise, Seiji Maehara, chief of the Policy Research Committee of the ruling Democratic Party of Japan, announced on Sept. 22 the formation of a project team to weigh in on the controversial issue.

The DPJ hopes to decide Japan's position by November, when nine countries intending to join the TPP --Singapore, Brunei, Chile, New Zealand, the United States, Australia, Peru, Vietnam and Malaysia --aim to reach an agreement on its framework.

But DPJ legislators expressing reservations or outright dissent to the free trade framework have swiftly stepped up their opposition to Japan's participation.

Unlike a free trade agreement and economic partnership agreement, all tariffs would be scrapped in principle under the TPP.

That means that Japanese rice growers, operating on a smaller scale, would be put at a serious disadvantage in price competitiveness, compared with their foreign rivals if Japan joined the TPP.

Japanese rice farmers are now protected by a 778 percent tariff imposed on imported rice.

But Diet members are concerned about more than just rice and other agricultural produce as likely fallout of the free-trade initiative.

Masahiko Yamada, a former agriculture minister who chairs a suprapartisan group of Diet members who are advocating a cautious approach to the TPP, and Masako Okawara, a group member, met with DPJ Secretary-General Azuma Koshiishi on Sept. 22 to submit a request asking to proceed with caution.

"Since the TPP would have serious implications on the lives of the public, including in health care, employment and safety standards, we need to take the time to hold a nationwide discussion," read the request.

In response, Koshiishi replied, "(The participation in the TPP) is a grave issue and its ramifications would not be limited to the agriculture sector.

I will tell Noda that he should handle the issue carefully."

Referring to Noda's meeting with Obama, Koichi Yoshida, chairman of the Lower House Committee on Agriculture, Forestry and Fisheries, said, "It is premature. Japan should not move quickly over the matter."

An Upper House member who is familiar with agricultural policies criticized the prime minister for pushing the discussion on the TPP.

Noda's predecessor, Naoto Kan, set Japan's participation as a key policy agenda for the international community.

Japan was initially expected to decide if it will join the talks to participate in the free-trade initiative by June.

The discussion, however, has been delayed following opposition within the DPJ and by the March 11 Great East Japan Earthquake and tsunami crisis.

Although Noda is set to decide at an early date, his administration has yet to reach a consensus on the contentious issue.

While Maehara and Yukio Edano, economy minister, are known to be proponents of the TPP, Michihiko Kano, who has been reluctant to support the free trade initiative, was retained as agriculture minister in Noda's Cabinet.

Kano reiterated a note of caution about the TPP in a news conference on Sept. 20.

"We need to obtain various information to discuss the issue," he said. "At this stage, it is hard to set the deadline for reaching a conclusion."

Nearly half of the DPJ members in the Diet are believed to be cautious about or opposed to Japan's participation in the TPP.

Many of them are close to Ichiro Ozawa, a former DPJ president and kingpin, and Yukio Hatoyama, Kan's predecessor.

Some DPJ members appear reluctant to point a critical finger at Noda following his efforts to bring solidarity to the party through Cabinet and party leadership appointments. The party had been in disarray due to infighting.

But the opposition is expected to grow toward November as discussion on the free trade agreement heats up.

Koshiishi, who plays a key role in bringing the party together, told his colleagues that it is "premature" to proceed with the discussion.

U.S. encourages Japan to join Pacific trade pact

WASHINGTON -

The United States said Thursday it would welcome Japan's participation in a future trans-Pacific trade agreement as it voiced frustration at a lack of new initiatives tying together the two allies.

Japan is debating whether to join the Trans-Pacific Partnership, a trade pact being negotiated by nine nations including the United States, but the government faces strong opposition from farmers.

Kurt Campbell, the U.S. assistant secretary of state for East Asia, said that Japan and the United States needed to find new areas for cooperation and that the trade agreement was a "possible venue."

"We need to have a conversation - a more straight-forward conversation - with friends like Japan about how we can find areas that we can work together"

on, Campbell told a conference of the Pacific Economic Cooperation Council.

The United States has been alarmed by a lack of momentum in its alliance with Japan, which has had a new prime minister each year since 2006, although many Japanese welcomed the rapid US response to its tsunami and nuclear crisis.

"I'm struck that sometimes when we meet we have huge challenges that we deal with, like how to respond to the nuclear challenge," Campbell said.

"We need to find areas-positive, outward, engaged initiatives-where the United States and Japan can chart a new course, not just strategically but economically," Campbell said.

The United States and eight other countries -Australia, Brunei, Chile, Malaysia, New Zealand, Peru, Singapore and Vietnam-hope to announce a framework on the trade deal at an Asia-Pacific summit in November in Hawaii.

President Barack Obama's administration has promoted the Trans-Pacific Partnership as a new type of deal that ensures labor rights and environmental standards, although globalization critics complain of a lack of detail.

Japan's Central Union of Agricultural Cooperatives has campaigned vigorously against participation, saying the deal would reduce food security in a country where farmers -especially of rice-enjoy generous government support.



U.S. unhappy with Japan's delayed decision on free trade talks

TOKYO — The U.S. government voiced strong discontent last month with Japan's postponement of a plan to decide by June on whether to join negotiations for a U.S.-led Pacific free trade accord in the wake of the March 11 catastrophe, sources close to the bilateral relations said Monday. The discontent was conveyed to the Japanese government through diplomatic channels, the sources said.

In a policy guideline adopted May 17, the Japanese government said it would "comprehensively consider when to make a decision" on whether to join the talks on the Trans-Pacific Partnership, a regional free trade initiative being negotiated by the United States, Australia and seven other Asia-Pacific countries.

Before the magnitude 9.0 earthquake and tsunami devastated Japan's northeastern region and crippled the Fukushima Daiichi nuclear power plant, the government said it would decide by around June whether to join the talks. The TPP is intended to require member economies in principle to scrap all tariffs.



The government also decided to put off a plan to work out in June a basic stance on reform of the nation's agricultural sector which is staging the main opposition to the TPP, fearing that it would be hit hard by an influx of cheap agricultural imports.

A senior White House official voiced strong discontent with the delay in Japan's decision on TPP negotiations at a time when Tokyo is moving ahead in talks on free trade agreements with the European Union as well as China and South Korea, the sources said.

Another U.S. government official concerned said the postponement had made it difficult for Japan to join the first group of nine economies leading negotiations for the TPP accord, they added.

Against the backdrop of these developments, Prime Minister Naoto Kan said Japan would make a decision in the near future on whether to participate in TPP talks when he met with U.S. President Barack Obama on the sidelines of the summit of leaders from the Group of Eight economies in France in late May.

The United States hopes that the nine negotiating partners, which also include Chile, Brunei, Malaysia, New Zealand, Peru, Singapore and Vietnam, will reach a broad agreement on the TPP before the summit of the 21-member Asia-Pacific Economic Cooperation forum in Honolulu in November.
